# Meeting of the Medical Radiation Practice Board of Australia

23 August 2012

The Medical Radiation Practice Board of Australia (the Board) met for the second time on 23 August 2011. The Board considered a number of key issues relating to the registration and accreditation of medical radiation practitioners.

Under the National Registration and Accreditation Scheme, registration and accreditation will become mandatory for Aboriginal and Torres Strait Islander health practitioners, Chinese medicine practitioners, occupational therapists and medical radiation practitioners from 1 July 2012.

#### Stakeholder consultation on draft registration standards

The Board agreed to release a series of draft registration standards for stakeholder consultation over a six week period from 29 August 2011 until 7 October 2011. These standards will include the five mandatory standards covering professional indemnity insurance, matters about the criminal history of applicants for registration, requirements for continuing professional development, requirements for English language skills and requirements in relation to recency of practice.

The Board also agreed to release an additional standard for consultation over the same period covering grandparenting and general registration eligibility arrangements.

Stakeholder feedback will be important in informing the development of the final draft standards which the Board will submit to the Australian Health Workforce Ministerial Council for approval.

The Board will publish all submissions, unless marked as confidential, on its website to encourage discussion and inform the community and stakeholders.

#### Accreditation

Following a decision by the Australian Health Workforce Ministerial Council (AHWMC) to leave the decision on accreditation arrangements to each Board, the Board agreed that the accreditation functions in relation to the medical radiation profession will be carried out by the Australian Medical Radiation Sciences Accreditation Council.

#### **Communications Strategy**

The Board acknowledged that an effective communication strategy incorporating practitioners, governments, the Australian Health Practitioner Regulation Agency, and other key stakeholders will be crucial to the commencement of the new national arrangements by 1 July 2012.
